The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates.

GENERAL TERMS & CONDITIONS

1. Rate may be quoted in one lumpsum for Vessel
2. The agency should be a Registered Agency/Firm in the field of Scrap/Trading Dealership.
3. The agency should have income Tax Clearance Certificate
4. The Agency should have valid GST Registration Certificate.
5. Acceptance of the **Higher bid (H1 Bid)** will be communicated to the bidder by CIFT within a period of 30 (thirty) days from the date of close of auction.
6. After the approval of the highest bid by the ICAR-CIFT 10% plus applicable GST of the highest bid will be deposited with in 4 (banking) days after completion of bidding process in the ICAR-CIFT and the balance amount shall be deposited on approval of the highest bid by the competent authority within the specified time as mentioned in the work order and the vessel to be taken over from the possession of ICAR-CIFT and removed from the berthing location within 45 days from the date of balance payment paid. The EMD will be returned only after clearing the vessel from the berthing location. **In case the bid money is not deposited time period, the earnest money and entire bid amount deposited shall be forfeited.**
7. The Agency's terms and conditions, if any, must be furnished along with the quotation letter.
8. GST rate is applicable as per rule.
